## VALLEY PATRIOT OF THE MONTH

### HERO IN OUR MIDST - SGT. MAJOR ERIC NELSON, 1983-2007

While attending the North Andover Veteran's Day observances, I was privileged to listen to guest speaker Sgt. Major Eric Nelson.

Nelson is a retired U.S. Army officer of 24 years. he spent his first career in the U.S. Army and is now spending his second career working for Valley Works in Lawrence helping other veterans find jobs. During his speech to the North Andover residents, Nelson talked about honor, bravery, commitment, sacrifice and what it means to be a soldier. These are the values that make up a "Valley Patriot of the Month" and that is why we chose Sgt. Major Eric Nelson.

Eric Nelson was born on May 31, 1965 in Lowell and attended University of Massachusetts in Lowell. He graduated in 2011. Prior to enrolling at UMass Lowell, Sgt. Major Nelson had a distinguished

military career beginning in 1983 when he enlisted in the U.S. Army. He joined the Army as a Field Artillery Fire Support Specialist and trained at Fort Sill, Oklahoma.

Upon completion of his training, Nelson attended Airborne School at Fort Benning, Georgia. He then joined the 82d Airborne Division at Fort Bragg, NC from 1984 to 1987. From 1988 to 1999 he was part of the 56th Medical Evacuation Battalion, Air Ambulance at Fort Bragg and the 3rd Military Intelligence Battalion. During that time Nelson also flew numerous combat missions in Saudi Arabia and Iraq as an Aeroscout Observer Section Sergeant during Operation Desert Shield and Desert Storm.

In 2003, Sargeant Major Nelson was an Aviation Mission Operations Manager for the 4th Aviation Brigade stationed in

Baghdad, Iraq. During that mission, he trained over 300 personnel on convoy operations with no combat accidents or injuries. He also led and managed a team of 15 staff in an Operations Center responsible for assigning missions and tracking aircraft and ground vehicles throughout area of responsibility, 24 hours per day.

He developed, planned, and implemented training to track the movement of 2,000 personnel, 50 helicopters, and over 300 ground vehicles daily. Because of his outstanding contribution during this time, most notably through developing realistic training that directly influenced the combat success of the organization, Nelson was awarded the Bronze Star Medal.

In 2004 Sergeant Major Nelson became a Senior Aviation Trainer and

# Secretary Galvin's Law Breaking Cannot Be Tolerated

Four years ago our impotent Attorney General Martha Coakley prosecuted State Treasurer Tim Cahill for running state lottery commercials with our tax money while he was running for governor. State law prohibits elected officials from using tax dollars for advertising 90 days before an election if their name appears on the ballot.

# Rep. Jim Lyons Fighting Taxes

Jim Lyons of Andover, incumbent State Representative for the 18th Essex District, met with some of his supporters last month and spoke about his continuing fight against “higher taxes, reckless spending and waste in government” in the Massachusetts General Court. Last week, at his 4th Annual Lyons Summer Campaign Cookout, looking relaxed and confident, Jim talked about the serious problems facing Massachusetts: out of control state budget, a bloated and over-spending bureaucracy, and the higher taxes the citizens of Massachusetts pay that results in a cut in aid to local cities and towns.

Jim spoke of his vote against the Fiscal 2015 State Budget. Since 2008 the state budget has increased from roughly \$27 Billion to the proposed budget close to \$40 Billion.


Raising the controversial sales tax in 2009 from 5% to 6.25%, he said, has not prevented drastic cuts to local aid. The sale tax increase has not been a help to working families and local businesses.

The tax passed last year by the Democratic leadership raised the gas tax to the Consumer Price Index (CPI). This means that every year the tax can increase forever without any further vote. What will that mean for the Commonwealth?

Calls for investigations into the Budget for 2015, by examining state aid for local cities and towns, education funding, and welfare reform was compromised. “Therefore a vote for the budget could not be made in good conscience” he stated. Transparency and openness must be a part of the process in voting for the budget. Many cities and towns in the Commonwealth have been put in the position of increasing local taxes, in order to provide services.

Running a state is vast and complicated. Emergencies, support for services and every day routine programs need to be funded. But, careful use of tax dollars is a priority.

Where do the tax dollars raised by the state of Massachusetts go? What programs do they provide? Are the tax dollars used in a prudent manner or are they used for “ favorite” projects by state

departments? These questions need to be asked and answered.

Jim and fellow representative, Marc Lombardo of Billerica, introduced a resolution that called for the Department of Children and Families to release Justina Pelletier into the care of her parents. This “egregious overreach” by the DCF has been the topic of discussion in newspapers, radio and television, throughout the country. The publicity from this case has raised questions of the cost of this case and what it has cost the Commonwealth in tax dollars. Some estimates have been as high as \$400,000.

Other expenses that have been charged to the state include in-state tuitions for non-citizens, medical benefits for “gender reassignment” for incarcerated prisoners, among many. All without input from the General Court; just through executive orders of the Governor Deval Patrick.

The support of many citizens of Massachusetts is reflected in the growing numbers of young people who are taking a place in state politics from a fiscally responsible position. Jim Lyons and fellow members of the General Court are encouraged by the enthusiastic and strong support of everyone who looks forward to a state that supports its citizens and preserves their values.

# Soul Searching at North Andover High

When Justin Bilton asked his English class to read the memoir, “All Souls: A Family Story from Southie,” something amazing happened. Even his least enthusiastic readers read the book from cover to cover. In fact, they were so moved that they wrote letters to author Michael Patrick MacDonald. Seeing an outreach opportunity, Michael offered to come to their school and share his wisdom and his message of hope.

Bilton planned a two-day event around the visit, inviting nearby communities and the public to attend. The goal of the project was “to broaden our understanding of and improve our approach to the effects of violence, drug abuse and the resulting trauma.” Events were held at locations in North Andover and Lawrence on Thursday and Friday June 5 and 6.

I attended Friday’s events at North Andover High School. When MacDonald took the floor to share his life story, you could hear a pin drop. He spoke candidly about growing up in Southie (South Boston), an Irish-American, working class neighborhood controlled by mobster James “Whitey” Bulger, where “people didn’t expect to live very long.” He recalled having trouble responding when asked how many people were in his family. That’s because he started with 11 brothers and sisters and ended up with 7. Michael suffered the loss of 4 brothers. David and Kevin committed suicide and Frankie was killed in an armored car heist – all in their 20s. Patrick died when he was only 3 weeks old. His sister Kathleen spent 3 months in a coma after falling from a roof while under the influence of drugs. Michael used to lie just so he would not have to explain.

Although it was rarely talked about, Southie in the 1980s had the highest concentration of poor whites in the country. Seventy five percent of the families were without fathers and 85 percent were on welfare. The author recalled being humiliated when he tried to buy movie popcorn with food stamps.

MacDonald described having a “heavy head” much of the time. That was until he met a therapist who was moved to tears when he revealed his childhood trauma. That encounter was a turning point in



his life. He said that for the first time, he realized this way of life was not normal and he felt worth caring about. In 1990 he “transferred all that pain and trauma into something positive,” by becoming a community organizer. The author left behind the strict code of silence that permeated through Southie and found his voice through writing.

Even after leaving his old neighborhood, he kept being pulled back, mostly to attend wakes and funerals at Jackie O’Brien’s Funeral Parlor. He needed some distance from his community to see it more objectively. What struck him most was that although his was a white neighborhood, it had the same crime, drug and alcohol problems black neighborhoods had. The difference was that nobody was allowed to talk about it.

MacDonald lived through the race riots of the 1970s. When Brown vs. Board of Education made desegregation possible, out of touch bureaucrats decided it would be a great idea to mix the Boston’s poorest whites with the poorest blacks. According to MacDonald, “Bussing re-segregated our community.” The disaster that ensued is now an ugly part of Boston’s history. This was a perfect example, he said, of the need for local control when attempting to solve problems within a community.

MacDonald asked the students if they knew what community organizing was. Surprisingly, not one student raised their hand. He explained that even NAHS is a



# Methuen to Use Shooter Detection Technology in Schools

Methuen Police Chief Joe Solomon appeared on 980WCAP's Paying Attention Radio Program earlier this month to reveal a new safety measure being implemented in the Methuen schools to increase response time and give police a tactical advantage when dealing with school shootings.

Solomon has been the Chief of Police in Methuen since 2002, and has been a police officer for 28 years. He says he is not a politician and doesn't really care about political ramifications when it comes to saving the lives of kids in schools, admitting that privacy advocates may object but it's for the politicians to decide the political questions.

Solomon told the WCAP audience that being prepared for the worst is a lot better than reacting to a situation without the right tools, saying the indoor shooter detection system is one more tool to help them save lives in times of school emergencies.

The system detects a gunshot, immediately alerts police, and allows police to instantly see a map of the building on their phone and in their cars, a schematic of the room or rooms the gun was fired in, and transmitting valuable data in real time to handle one or multiple school shooters.

**WHAT IS THE INDOOR SHOOTER DETECTION SYSTEM?**

"I think the way we are trying to explain it is, [it's like] a smoke detector for gunshots. We have a smoke detector and carbon monoxide detector, why wouldn't we want a shot detector?" Solomon asked.

"In Methuen we have been saying since the early 90's we want layers of protection," adding "there is no one fix or solution."

Solomon says that the indoor shot detection system can be integrated into alarm or camera systems in any school and has been used by the military for years to detect the location of gunshots on the battlefield. The device was initially developed by the military and was former Secretary of Defense Gates last orders to allow the technology to be publicly available. The system is being marketed and produced by a local company in Rowley Massachusetts called "Shooter Detection Systems." Methuen police have been working with Shooter Detection Systems for about 18 months.

"We are working with two other communities in the area," Solomon said, adding that he was not going to name the communities until they announce it themselves.

"We asked them to join in with us, so, initially it will just be in a pilot program in Methuen. We are working on a grant from the Department of Justice to make it a regional attack on this problem and then we are also working with a public university which, at this point we can't name, who are going to do a research study for us."

**TESTING IN THE SCHOOLS**

"Indoor detection is new, but this is a tried and true technology. It comes out of the "Boomerang X" which was developed through a defense contractor and has been in use overseas for years by our military. It's a little circular device you wear on your shoulder and when the marines and special forces are out in the field, and a gunshot is fired, from a mile away or 200



feet away ... they can look at it and it gives you the GPS coordinates and gives you a clock point. So, we were able to obtain a couple of those and we gave them to our special operations team and did some testing with them."

"We did multiple tests inside our schools, at night and during the week, and during the day, we tested a variety of different weapons. We tested everything from handguns to assault weapons"

Solomon says that Methuen police tested weapons "as factory made" and guns that were modified with silencers. He says the shooter detection system had 100% success detecting shots in the schools they tested.

"What we liked was that it could detect a muzzle shot from a flash and the sound. This has dual capabilities so you can compare the two, to confirm there's a shot."

Solomon says that the police also tested various every-day sounds to see if it would set off the system as a false positive, but were unable to set off the device with any other object. The Chief worked with the

engineers at Shooter Detection System as they tested the devices, sharing all of the data Methuen Police collected during their tests.

"We used a team of officers, everybody has been through a SWAT 1 and SWAT 2 tactical training class, everyone were marksmen, and every one was part of a special operations team, so that we wouldn't have to worry about stray rounds in the schools. We wanted to cover every single base we had. We didn't want kids to come to school to see holes in the walls."

**RESPONSE TIMES IN SCHOOL SHOOTINGS**

"The biggest problem police have is: what is the time it takes from something occurring, to being reported? Once it's reported and police arrive at the scene, how much time is it from arrival to the time of contact, because now the person has moved?"

"With the system being automated, as soon as the gunshot is detected it will send an emergency alert out. It will go to all our

## Hampstead Academy, An Opportunity For Your Child to Succeed

The Hampstead Academy private grammar school in Hampstead, NH was first opened in 1978 as the Atkinson Learning Center and services kids from pre-K through 8th grade.

The school is dedicated to teaching the "whole child". The school's founder Lyn Kutzelman says that the basic premise of Hampstead Academy is to try and develop curriculum that melds together with everything a child needs to learn.

"We really integrate all the subjects, like math, art and music. All the teachers are in close contact with each other so that they are not in isolated classes that have nothing to do with the next class, with us it all comes together."

Kutzelman says that even with special projects and field trips, students get a whole world approach to learning.

"We did an Oceanography unit through-

out the school for a whole year which touched on everything from the oceans of the world, to the explorers, to traveling up to the Piscataqua

River. We took the kids to show them the tagging of seals on Long Island Sound. They spent time at the University of Connecticut at the Seacoast Learning Center. Learning is not in isolation here. It's hands on. It's interrelated with a number of different subjects, so we incorporate math and science and social studies and art. We took them to the Aisle of Sholes and taught them the history of what went on out there.



They learned about our natural resources and what is happening with the pollution of our waters and what they can do about it."

James Stewart, Chairman of the Board at Hampstead says every learning experience at the school is "an opportunity to advance the mission without losing any of the tradition, values and principles that made this school great. That's what the board is really all about. Anything we consider doing here has to pass the test of, is it going to change the principals and values upon which this school was built?"

"The idea of teaching whole child development is something other schools may say they are teaching, and they may think they are doing it, but the difference is, in this school it isn't just the amalgam of all the different topics brought together in some sort of a cross disciplinary way, we also teach kids how to be good citizens."

"Often times our kids in kindergarten will be with third graders to do a project," Kutzelman added.

"Eighth graders may go back to the preschool and do a reading project, so the kids are helping each other and learning from each other. I truly believe that multiple age classrooms in many cases works much better for students because they can learn by working with other people and the younger kids look up to the older kids so we use that as a teaching tool. That's the way real life is. We learn from others."

Kutzelman says they do not teach to tests and she sees no need for children to

# Kathy's Lawrence Notebook

## Jobs, Jobs, Jobs

Good news, the Rental Inspection Ordinance was withdrawn at the June 17 Council meeting. Landlords in Lawrence, please obey the laws already in place and get an occupancy permit when tenants change.

Has anyone noticed that some councilors seem to think their most important job is Employment Czar? From the residency requirement to wanting intimate details of the hiring process and contracts for various city positions, the Council is obsessed with the hiring process.

The residency requirement passed as expected (6-3), at the Council meeting of June 17, so if the mayor signs it and the public does nothing we can expect it will become law. Is the residency requirement a good idea? I think it's a nice idea theoretically, but have reservations. For example, the city has been searching for a Treasurer for a couple of years. In that time, two people were hired for the position that didn't work out. Lawrence residents were certainly not excluded from this process. If the residency requirement goes into effect, will the city be forced to hire some minimally qualified resident for this position if we can't find an applicant willing to relocate? Will this requirement help the city hire the best people for jobs? How much needless suffering and litigation have the taxpayers already been through because of the unqualified hires in this city? I'm not singling out any administration, there's enough blame to spread around for all.

Should the voters mount a campaign to bring this issue to the ballot in November? I would sign a petition to do so, but think it would be more effective to try the requirement for a while. The city will remain divided over this issue unless we can see for ourselves if it works.

Other Employment Czar tasks include scrutinizing the number of applicants interviewed for each city position, and grilling candidates as to why they're the best person for the job. Councilor Aquino voted in favor of John Isensee for DPW Director in 2011 when her mentor, William Lantigua, presented him to the Council, but Mr. Isensee must have lost some of his qualifications in three years as she questioned him like a District Attorney cross examining a witness for the

defense this spring. The layoff and recall processes for city employees have been heavily scrutinized. These concerns seem to be an epiphany of sorts for some of the councilors, being entirely nonexistent during the term of the previous mayor. How many resumes were scrutinized before promoting Melix Bonilla to deputy police chief? Where was the desire for the most qualified candidate then? That's just the tip of the iceberg. Here's an idea: Let's post open positions, collect applications, do interviews, and then hire the most qualified candidates. It's worth a try.

Perhaps the most disturbing incident involves the company Asahi/America. This company is relocating its North American headquarters from Malden to Lawrence, in the old Staples Distribution Center on Andover Street. This includes warehousing, manufacturing, and R&D departments. A TIF (Tax Incremental Financing Agreement), which lessens the company's taxes for ten years, was negotiated by the administration. The City Council must approve TIFs. According to the company's web site, "Asahi/America is the leading manufacturer and distributor of thermoplastic fluid flow solutions including valves, actuators and piping systems to industrial, chemical, wastewater treatment and high purity markets." Asahi/America is exactly the kind of company that the City of Lawrence needs, a manufacturer. The TIF includes a provision that requires the company to hire seven Lawrence residents out of approximately twenty five jobs that are expected to be created, which can't be legally enforced but is a suggestion. This vote should have been a no-brainer, but not with our elected officials. Councilor Almonte thought that guaranteeing only seven employees from Lawrence was not quite enough.

We needed to know what kind of jobs will be offered to city residents and when they will be created. She stated that we are "offering" the company the space in our city so they will hire Lawrence residents and went on, "if we the city don't agree with this [TIF] and we say no, guess what, then they can't come to our city." Really? This reminds me of "Merrie Olde England" where you couldn't go on the King's land or shoot the King's deer without the King's permission, not the United States of America. I don't see some councilors being happy until they can award jobs like

**Lantigua, Targets DiZoglio, Supports Phil DeCologero in Rep Race**

You have to hand it to former Lawrence Mayor Willie Lantigua. Even as a private citizen, he continues to conspire for revenge against his so-called enemies and everyone he believes has ever slighted him, real or imaginary.

Not only has Lantigua been targeting Rep. Marcos Devers for defeat in Lawrence by running against him as an Independent, he also recruited Roger Twomey as a REPUBLICAN to split the split the anti-Lantigua vote, practically ensuring he regains his seat in a three way race come November.

But Lantigua isn't just targeting Devers for daring to help Mayor Dan Rivera defeat him in 2010. He is also targeting State Rep. Diana DiZoglio by throwing his support behind North Andover Democrat Phil DeCologero who, along with Oscar Camargo is challenging DiZoglio in a three way primary.

Candidates for local office, such as mayor or city council, however, could refuse to pay fines or file campaign finance reports and still have their names appear on local ballots. DiZoglio's bill changed that and now, municipal office seekers are held to the same standard as candidates for state office.

Legislators called it the Lantigua Bill because Willie Lantigua ran for mayor in 2010 with multiple campaign finance violations and ran for reelection last year still

refusing to comply with state's campaign finance laws.

**LANTIGUA'S REVENGE**

In the past few weeks, Lantigua has told supporters and candidates for other offices that he is supporting DeCologero because he wants to make DiZoglio "pay" for publicly humiliating him with her bill, as if that was her only goal. It's obvious that Lantigua doesn't have any respect for campaign laws, and now DiZoglio has made it harder for him to flout those laws.

For his part, Phil DeCologero told The Valley Patriot that he never sought Lantigua's support or endorsement, following up with "I would think Lantigua would not be happy with me since I campaigned for Dan Rivera for Mayor."

What Phil DeCologero did NOT say in that interview is that he would refuse to accept Lantigua's support or public endorsement saying he "cannot control who supports or votes for me, no candidate can."

But, you can't blame Phil for not publicly refusing Lantigua's support. After all, Lantigua's influence is still very strong and his supporters could put Phil over the top come September. Additionally, who wants to piss off the king of dirty politics when they are in a very close race for state rep. themselves?

**House Passes Law To Require Donor ID For Super PAC Campaign Contributions**

The House of Representatives recently passed legislation that will substantially increase the disclosure of specific donors to Super Political Action Committees (PACs).

This was a direct response to the ever increasing influence that 'dark money' or undisclosed contributions had in the most recent Boston Mayoral race, and the expectation it will have a great impact upon the coming race for Governor.

As the Vice Chair of the Election Law Committee, I knew that the Boston mayoral race was going to highlight the changes allowed under 'Citizens United' passed in 2010 by the U. S. Supreme Court. The non-disclosure law resulted in Super PACs and many labor unions pouring approximately 4 million dollars into Boston's last November Mayoral race.

In this race, a PAC with unidentifiable contributors spent approximately \$480,000.00 on television advertisements immediately before the election promoting Marty Walsh for Mayor. By law, under the Supreme Court Ruling "Citizens United," this was all quite legal.

In January, following the election, it was disclosed that these funds came via the "One Boston" PAC through a New Jersey PAC that that does not file any campaign disclosures in New Jersey. After the election, the American Teacher's Association disclosed that it was the entity that had funded the "One Boston" PAC.

The public wants more disclosure. We all understand and want to protect our rights and the rights of others to contribute

to candidates. However, we also want to know who really is speaking to us, who is giving large sums of money, game changing sums, to sway us to whichever candidate they favor. We simply want to know where labor, corporate and non-profit money is coming from and where it is spent. This legislation is an important step in this direction and will place Massachusetts as the national leader in helping voters to be able to follow the money.

Under this legislation, PACs will have to disclose their funding sources within seven days of each expenditure they make, and every 24 hours during the eight days before a primary and general election.

Also, very importantly, is that PAC television and print ads will have to list the top five persons or entities that contributed the most money to their advertisements.

This legislation will also double the amount that individuals can contribute to individual candidates from \$500 to \$1000.

This contribution threshold has not been raised for over a decade and is well behind that of other states.

The vote received bi-partisan support and passes to the Senate. The legislation must be agreed upon by both branches of the legislature before the current legislative session ends on 31 July.



Andover Selectman and candidate for the State Senate, Alex Vispoli called for an end to legislative per diems that pay for legislators commuting expenses.

"It is time to end this special perk of legislators," said Vispoli. "I find it incredulous that the Senate would vote to link the gas tax to inflation while they get this special perk which means they don't feel the pain at the pump like the rest of us. Senators should have to pay to drive to work like everyone in Andover, Dracut, Lawrence and Tewksbury do."


Senators can claim a per diem for every day they go to the State House. The amounts vary from district depending on the distance representatives have to drive to the State House. It ranges from \$10 per day to \$90. Last year Senator Stan Rosenberg claimed the most in per diems. He accepted \$12,840.

Vispoli says he plans on filing legislation to end this perk for legislators. Vispoli is also opposed to raising the gas tax annually. He has been part of the effort to repeal the gas tax being linked to inflation. Vispoli has signed a pledge to abolish per diems and not to take per diems when elected.

**Three Suspects in Custody After Wild Chase Leads to Stolen Cruiser**

LAWRENCE - Salem NH police lead a chase through the streets of Lawrence early Saturday morning after a Salem Officer was assaulted on a routine traffic stop.


The driver, with at least two other occupants fled the scene and led police on a chase that landed them on Essex Street in Lawrence at the height of the club activity down town.

The officer who had been assaulted during the stop (Officer Adam Pearson), shot the drive with a taser but the driver pulled out the taser wires and fled. Pearson lead the chase down Essex Street, as the driver of the fleeing car sped through red lights, weaved in and out of nightclub traffic, barely missing one pedestrian, and crashing into a concrete median strip in front of MacDonald's on Essex Street.

There were no civilian injuries during the Essex St. portion of the chase. We have no information if anyone was hurt prior.

The Valley Patriot followed the chase as Officer Pearson followed the suspects to the top of Tower Hill where steel from the blown out tire and skid marks could be seen in the middle of the road. (see photo)

The Valley Patriot caught up to the car



stopped on Essex St. just past the intersection of Essex and Nesmith.

The driver of the car had exited the vehicle, assaulted the officer, threatened his life and then jumped into the Salem police cruiser, speeding off towards Water Street.

Officer Pearson drew his gun on the two suspects in the vehicle and called for backup but within seconds a Lawrence police car arrived and the two remaining suspects were arrested. They were held in Lawrence for a brief time and transported back to Salem NH to be booked and processed.

State, Salem, Lawrence and Essex County Sheriff K-9 units scoured the Water St. area and found the cruiser on Merrimack Terrace. Police tried to locate all of the weapons in the vehicle at one time a partial radio transmission was

heard calling for an accounting of an automatic weapons and that the suspect had threatened "to kill the first cop I see". One officer was heard on the radio saying that the suspect had fled near the woods by the Merrimack River.

Police apprehended the suspect about an hour later. He was identified as Pennsylvania resident Robert Zygarowski. Zygarowski was arraigned the following Monday. A Rockingham County judge ordered Zygarowski held on \$500,000 cash bail or surety.

Zygarowski was charged with two counts of simple assault, two counts of criminal restraint, two counts of resisting arrest, reckless conduct, reckless driving and disobeying a police officer.

A probable cause hearing was held on July 2nd.

# Obama Sends 7 Planes of Illegal Aliens to Hanscom National Guard was Notified but Patrick Denies Knowledge



Xtra Airways plane filled with illegal aliens lands at Hanscom Air Force Base to secretly disburse them into the population through the state's Department of Children and Families.

According to Massachusetts Secretary of Public Safety, Andrea Cabral, at least seven flights filled with illegal aliens landed in Massachusetts. The planes transported illegals from the Mexican border to the Bay State prior to April 18, 2014.

A letter from Cabral to Massachusetts House Minority Leader, Brad Jones, admits five flights landed at Hanscom Air Force Base, two were diverted to Logan.

"These flights were routine transports of detainees either to detention facilities in Massachusetts or outward bound for deportation," Cabral wrote to Representative Jones on June 19.

Despite Massachusetts Governor Deval Patrick denying he had any knowledge of the illegals being shipped to Massachusetts, Cabral's letter points out that the State Police and the National Guard were notified prior to their arrival.

"The State Police provides 24/7 security at all state-owned airports in the Commonwealth, and as such, was aware of and present for all seven flights. The National Guard was also aware of the flights landing at Hanscom AFB. Assisting a federal law enforcement agency with such temporary transportation stops is routine

and there were no extraordinary costs incurred."

Despite Valley Patriot sources at DCF who say that the minor children transported into Massachusetts are being filtered through the DCF foster care system, Cabral's letter disputes that.

"No Detainees were released in Massachusetts, and we are aware of no ICE policy or practice that would permit that. Further," Cabral's letter continues, "no unaccompanied minors were included on the transports."

This is also in direct contradiction to Valley Patriot sources who say that unaccompanied minors were indeed part of the transport, and some have already been reunited with family members in Massachusetts.

"ICE detainees were conveyed either to outbound flights for deportation or to state and county correctional cells to await deportation," Cabral said in her letter.

"None of the detainees is (SIC) using any of the Commonwealth's safety net services."

A spokesman for Hanscom says that no illegals are being housed on the base.

Thank you for your recent inquiry to the Governor into the Immigration and Customs Enforcement (ICE) transport stops in Massachusetts.

Since April 18, 2014, when the transports began, there have been seven ICE chartered flights to the Commonwealth. Five flights landed at Hanscom Air Force Base, and two were recently diverted to Logan International Airport due to an emergency at Hanscom AFB. These flights were routine transports of detainees either to detention facilities in Massachusetts or outward bound for deportation.

The State Police provides 24/7 security at all state-owned airports in the Commonwealth and, as such, was aware of and present for all seven flights. The National Guard was also aware of the flights landing at Hanscom AFB. Assisting a federal law enforcement agency with such temporary transportation stops is routine and there were no extraordinary costs incurred.

No detainees were released in Massachusetts, and we are aware of no ICE policy or practice that would permit that. Further, no unaccompanied minors were included on the transports. ICE detainees were conveyed either to outbound flights for deportation or to state and county correctional cells to await deportation. ICE pays a per diem to the custodial agency for that service. The Commonwealth incurs no extraordinary costs.

In short, the Commonwealth's involvement in these transports is limited to providing routine security at the airport and routine custody, for a fee, for those detainees housed temporarily in state or county facilities. None of the detainees is using any of the Commonwealth's safety net services.

If you or the Members of your Caucus require further information about these transportation flights or the process by which ICE facilitates detainee deportation, I would urge you to contact the ICE New England Region Public Affairs Office at 617-565-5400.

Devers faces two opponents on the November ballot, former Lawrence Mayor Willie Lantigua is running as an Independent and his ally Roger Twomey is running to divide the anti-Lantigua votes as a Republican.

## A BITTER RIVALRY

Devers was elected in 2010 when Lantigua was forced to resign after being elected mayor. Members of the legislature were furious that Lantigua was holding two public jobs and threatened to kill a \$35M bailout loan for the City of Lawrence saying Lantigua was "double dipping".

After losing his reelection for mayor to Dan Rivera by 81 votes, Lantigua told The Valley Patriot back in November, "You can tell your friend Marcos I'm coming after him, and if I have to put someone else in the race to beat him, I'm going to." Lantigua also said when he reclaimed his legislative seat he was going after Mayor Dan Rivera next.

Devers endorsed Rivera over Lantigua last year in the mayor's race, something Rivera says he will not forget.

## RETURNING THE FAVOR

"When I was running for mayor we really did do something spectacular," Rivera told the crowd from the microphone. "If it wasn't for a lot of the people who support Marcos, I would not be

mayor today," he said to the applause of the crowd.

"Marcos is my State Representative at 12 Jefferson Street, and we are very proud of him and the work that he does for our city. More importantly, when I was running for mayor he made a really big decision to support me [against Lantigua] and for me that was an honor."

"At the end we came together, and Marcos and the others who we fought together, I am so, so grateful."

"So when somebody said 'oh Marcos is going to have a race' I thought well, people have races all the time, and then I was told somebody specific is going to run against Marcos (Lantigua) I said 'Oh my God', Mayor Rivera said taking great pains not to mention Lantigua's name.

"But then I said, OK, now we are go-

ing to do exactly what we did before, we are going to work hard, we're going to come together and we are going to show people that the good people of Lawrence want good representation at the State House. They want honest representation at the State House. They want somebody who works hard, and looks like us, and talks like us, and has our experiences and that's Marcos Devers."

"I'm glad you all helped me become mayor, I'm very thankful, I'll never forget all your faces. The time we spent in the rain, the cold, knocking on doors, making phone calls, that made the difference. All of you made the difference. I think we have to do the same thing now. We have to work hard. We only won because we worked harder. We worked more positively. We've got to make sure we do that again for Marcos, he definitely deserves it. But, not so much because he deserves it, this thing about candidates isn't so much about us the candidates it's about you. He deserves to be put back [in the legislature] because we deserve the quality of the guy Marcos Devers is. Let's go Marcos!"

## SUPPORT IN THE HOUSE

House Majority leader Rep. Ron Mariano (D) Quincy also spoke on Devers' behalf.

"As I look out I see an array of house members who are here to support Marcos," Mariano said.

"We are here because Marcos is our friend, because we believe what Marcos stands for and what he does for his com-

cruisers and our laptops. It will come in as text messages or apps on our phones, it takes the human error out."

"In situations like this it turns out not to be seconds, it turns out to be longer because someone has to run for cover, they have to get somewhere safe, they are shaking, they have to get their phone out and, what we found out is, when they call they are either whispering or they are hysterical and it takes a while to calm them down."

"If you could save 30 seconds to a minute... some of the first calls that come in during a shooting scene in schools have been three minutes. Think about the amount of devastation you could reduce. The second part is, we have the opportunity to have a microphone turned on, and a camera in each system. So now you can listen to what's going on in the schools, you can hear where the shots are, and if more shots are fired it gives you the locations in the school because each one of them is going to have a GPS locator."

## EYES AND EARS IN THE SCHOOLS

Chief Solomon says that the indoor shooter detection system will allow police to talk directly to a shooter through the system. He says that those camera and microphone features are optional depending on type of facility the system is used in.

The Methuen Chief says the most important advantage he has seen with the system is that, when his officers arrive at the scene they know exactly which room the suspect is in within the building, giving them a tactical advantage to save

children's lives. He also said that the technology exists to take the shooter detection system and use it outdoors for example, in high crime neighborhoods. This would immediately detect when a gun has been used.

"The advantage of being a cop and not a politician is that I don't have to worry about political views. It may harm me [publicly] because some people may be upset over it, but I have a job, and my job is to worry about law enforcement. You might not agree politically, you might think it's a bad political statement particularly even talking about security. But, we do what we need to do by looking at technologies like this and trying to work together as a team to say "what can we envision happening in two or three years, because this is a long term project."

## LOCAL COMPANY DRIVES CUTTING EDGE TECHNOLOGY

Chris Connors, founder and head of Shooter Detection Systems in Rowley called into the show to discuss school shootings and how his product can save lives. He says the system is easy to install but stopped short of saying how much it would cost for a municipality to purchase, as technology is still so new for urban use.

"What we did was, we took the military capability and put it in a benign looking box that would look the same as a switch or an outlet you may have, so it fits into a standard electrical box. You screw it in and have it up and running in a couple of seconds."

"What's been developed in the last 10 to 15 years by the department of Defense ... is basically to write the best algorithm software that can understand, listen for the sound of a gun shot, and pick that out from other noises, which is the key. You can't have false alerts especially in schools."

Connors says that even with silencers "there is some energy that comes out of the weapon, so we combine both listening and looking, and then immediately let everyone know that a shot has occurred in that area."

"When you look at Sandy Hook where was six minutes, almost, for someone to call the police and the last death that happened was ten minutes after it started. If you can do the simple math and just save those six minutes, I think children's lives would have been saved."

Connors says that they are installing the system in a major airport this summer "it's going to be a temporary install" and his hope is to bring the product to market and make it commercially available for private use. Connors says that all the devices are made in the United States.

## METHUEN HAS POLICE IN EVERY SCHOOL

"We are very lucky in Methuen we have a police officer in every single school. Not only do we have an officer in every single school but we have a sergeant assigned to supervise the school officers and visit every school."

Tom Duggan posed a question to Chief Solomon: "The media tells us putting cops in schools doesn't work, but you have proof that it does work, don't you?"

"Oh we absolutely do," Solomon relied.

"This [cops in schools] is not about trying to just stop a shooter or reduce the outcome of a shooting, it's about build-

ing relationships and behavioral analysis. When an officer is working in a school, he develops a relationship with the students."

Solomon says that officers get to know the students and faculty in each school and it is easier to detect who the trouble students are. He also said that by having officers in the schools, they can be the front line if a problem occurs because the relationship they develop within the school gives them first-hand information about who or what they may be dealing with in a crisis.

"It's not about just walking around a school with a gun, it's about being the whole package, being a teacher, get in the classrooms and teach [safety]. I believe it is about situational awareness and behavioral analysis," he said.

"It's truly important to have an officer in every single school."

Solomon says that next school year, Methuen will have five full time school officers and one full time sergeant. "I know we are the first in Massachusetts; and I would bet we are one of, if not the first in the county, to have a police officer in every single school."





## Coming Out is Never Easy

When you fall love at the same time that your mother is dying, do you focus on love's beginning or life's end? In 1994 my heart was ripped in half by the two most important women in my life. Nothing, in my previous twenty-nine years, would have prepared me to balance what would prove to be the best and worst of times. Coming out is never easy, but it's a great deal harder when the one person you were counting on to help you with its process is diagnosed with terminal cancer and has months to live. That's where I found myself twenty years ago.

When my marriage dissolved, I moved in with my parents. We were all masters at keeping secrets from each other. I could see my mother wasting away, but in no way understood completely the hell that they went through every night when we each closed our bedroom doors. They sensed my loneliness and frustration, but likened it to a woman trying to come to terms with the end of her marriage and an uncertain future. They had no idea, at that point, that I was also wrestling with coming out. The wall between our bedrooms became symbolic of the wall we placed between us. It protected them from my truth and I from theirs.

I perseverated between coming out to my mother or not. I needed her to know before she died. Knowing that my mother knew me completely, loved me and accepted me as I am would give me the strength and confidence to push forward. I was naturally concerned for her present condition. She was sick and weak and I wasn't sure how she would handle the news. I prayed that I would make the right choice. Every time I thought it was a the right time, a family member would make a disparaging remark against homosexuals or some other aspect in my life would throw me a curve ball and my resolve would falter. It was an incredibly lonely and frightening time in my life.

I came out to my best friend, a wonderfully supportive and loving woman who saved my life that year. I joined a Methodist church that had just made a public statement about becoming open and affirming to the gay community. I attended gay, lesbian, bisexual, and transgendered support groups and social groups and began to create and extend my circle of friends. I was accepted and supported by these amazing strangers and yet still balked at coming out to me family for fear of rejection.

Every day I prayed for strength, guidance and hope. I was exhausted from praying. Some moments were more difficult than others. There were times that

I could see no end to my misery. Other times I would find hope and promise in my future. Every day I felt like I ate a bowl of anxiety. My belly was full of it as I watched my mother starve to death.

One day, out of the blue, I just blurted it out to my mother because I couldn't hold it in any more which is something most, if not all, gay people will tell you. For those of us who did come out and didn't live our lives as openly gay from the start, there comes a time that you can't ignore it any more and you can't hold it in. It becomes impossible like not letting the air escape your lungs while trying to hold it in.

When I told my mother I was a lesbian I apologized. Her exact words were, "I love you, Dani. I will support you no matter what you do. And don't ever apologize for who you are. I just want you to be happy." This is how every person who loves someone should be. I was elated and rejuvenated. I was feeling better in so many ways as a result of coming out to my mother. I felt stronger. I felt the tension I had been feeling for months begin to ease in my bones.

Shortly after telling my mother, I fell in love. This would prove to be as terrible as it was wonderful. When you fall in love you want to share it with the world, but I couldn't because I was only out to a couple of friends and my mother. How would my family react? Would they be angry? Would they think me selfish to do this at a time when our mother was dying? My mother was happy for me. I hoped that they would see this and be happy, too. My mother promised to help me with the family, but how long would she be around? How much strength did she have? I certainly didn't want her using it for me. She needed all she could muster for herself.

Before my mother passed, just eight short months after her diagnosis, I did come out to every one in my family. I didn't realize until years later that it was a coming out for them, too. They had readjust to seeing their little sister build a relationship with another woman. But, like my mother, they love me and want me to be happy. It was the most wonderful and terrible of years for me. To gain and lose so much at the same time split my heart in two.

Thankfully, I have a truly loving and supportive family. Isn't that what everyone should have?

## Supreme Court Hobby Lobby Verdict is Good for Four Reasons

Although the Hobby Lobby Supreme Court decision covers the rights of certain kinds of corporations, it has many potential ramifications. This decision is good for four reasons:

1) Contraception is not health care. Its intent is not to heal or promote human life, but to thwart it from being passed on. It does not facilitate proper female physiological function, but rather suppresses it.

2) Contraception is the opposite of health care: Contraceptive pills are not only listed as a class one carcinogen but its hormones do havoc to a woman's body ecology, causing many deleterious consequences to health, fertility, and mate selection.

3) It can cause early abortion. Many so-called "contraceptives" actually cause early abortion as a back-up mechanism. These include Plan B, Ella, the intrauterine device, and the common birth control pill, by "making the lining of the womb inhospitable for implantation" (webMD). The tiny human that begins at conception in his or her mother's fallopian tube ends up flushing out of her body.

4) It's a matter of religious liberty. For one, the Catholic Church teaches that contraception is an intrinsic evil because it separates the double-meaning of marital love, which is unitive and procreative, and its use is the matter of mortal sin. This means Catholics cannot cooperate in anyone's use of contraception without being in grave danger of losing their salvation; and providing employees contraception coverage is cooperation with evil.

Let's take a quick look at each of these four points.

First, contraception is not health care. No "can of worms" is opened because unlike religious liberty arguments against legitimate health care services such as blood transfusions or certain vaccines, contraception does not promote health and proper function. In fact, its primary purpose is temporarily to shut down a woman's reproductive physiology and manipulate her system by hormones to act contrary to her nature. Its goal is literally to transform healthy function to dysfunction.

Second, contraception is the opposite

of health care. Putting aside the grave consequences that contraception has had on the denigration of marriage, the breakdown of the family, neighborhood and community, as well as the very dangerous de-population implosion of the western world (see [youtube.com/watch?v=IZeyYIsGdAA](http://youtube.com/watch?v=IZeyYIsGdAA) on this), contraception does havoc on the body ecology of women, filling them with unnatural hormones that do serious damage.

Third, it is common knowledge that Plan B -- sometimes called the morning after pill or emergency contraception -- as well as intrauterine devices (the IUD) have back-up mechanisms that abort small children. Webmd.com in its more politically safe language states it this way, "(It) prevents implantation of a fertilized egg in the uterus by altering its lining." What is not common knowledge is that the birth control pill does the same thing, by "...making the lining of the womb inhospitable for implantation." All of these "contraceptives" have back-up mechanisms that in effect kill tiny human beings; and countless women who have taken the pill may have unwittingly had multiple abortions without ever knowing it. People need to be aware of this.

Fourth, religious liberty is a human right that the Constitution recognizes. No person should be forced by government to violate their conscience. If a potential employee does not like what a company covers they can apply elsewhere, just as if a Jewish restaurant does not serve pork a potential customer may eat elsewhere.

Most people who applauded this court decision did so on religious liberty grounds. They focused on some combination of #'s 3 & 4 above. Personally, I think #'s 1 & 2 above offer a stronger argument in a pluralistic society. Contraception violates natural law by doing havoc to a woman's health, polluting her system with hormones and suppressing her femininity. It cannot, therefore, be reasonably considered health care. Although religious liberty is important, it is a moot point here since contraception is not health care and should not be covered by anyone.

# Against Bullying? Start with Walmart

After years of harassment by special interest groups, Walmart is fighting back. As with most bullies, the claims they make have less to do with reality than with bolstering the tormentor's self-esteem.

This was evident in Timothy Egan's New York Times op-ed, June 19, 2014, entitled "The Corporate Daddy," where Egan accused the company of paying "humiliating wages." He claimed, "Working at Walmart may not make you poor, but it certainly keeps you poor. ..."

Responding to the NYT hit piece, Walmart's David Tovar, Director of Corporate Communications, reposted Egan's article, complete with snarky, red-inked edits in the margins. He began, "Thanks for sharing your first draft." Tovar proceeded to dispute claim after baseless claim. It reminded me of the triumphant scene in "Napoleon Dynamite," where the relentlessly mistreated protagonist earns a standing ovation for his dance moves.

With 2.2 million employees worldwide, Walmart is also the largest U.S. employer. The average full-time associate earns around \$12 an hour, well above minimum wage. In 2013, the corporation was praised by First Lady Michelle Obama for announcing plans to hire 100,000 veterans. Last year they donated more than \$1 billion to charity globally. They also offer education assistance and help associates who have been affected by catastrophic life events such as fire, divorce, death, etc. In the wake of Hurricane Sandy, the retailer sent truckloads of goods to help victims. Yet, their reputation is under constant attack.

The Washington Examiner reported that Walmart's health insurance is not

only more affordable than Obamacare, but it also offers better coverage, minus the income, age or gender restrictions. The retailer revolutionized the pharmacy industry by offering inexpensive prescription drugs with little to no co-pays for their employees. Still, nothing satisfies the bullies, intent on pushing Walmart down and taking their lunch money.

Walmart is known for their entry level positions. But starting wages are rarely static. According to their website, "About 75% of our store management teams started as hourly associates, and they earn between \$50,000 and \$170,000 a year ... Last year, Walmart promoted about 170,000 people to jobs with more responsibility and higher pay." This is a key point lost on the Walmart bashers -- as people gain knowledge and experience they climb the economic ladder.

It is clear the Walmart smear campaign is a pastime mostly enjoyed by far left activists, unions, angered by the superstore's refusal to unionize, and the politicians beholden to such groups. To protest the opening of Walmart stores in cities, like Brooklyn, New York and Boston, is to deprive consumers of a wide variety of quality goods at low prices. A 2011 NYT poll showed 62 percent of New Yorkers wanted a store in their neighborhood. In her blog, "Ghetto Economics & the Politics of Poverty," Stephanie Davis writes: "In essence, Boston's political class has turned its city limits into a type of food desert or island in which the cost of goods is higher because of limited supply or lack of competition."

Today's trend is to be obsessed with the gap between the highest paid worker and the lowest. Of course there's an income gap! But, we must also take into account the gap in initiative, experience and in



some cases, education (all of which can be rectified). These things being equal, we could legitimately criticize the income disparity. If career politicians and intellectual elites had even a smidgen of experience in the private sector, they might understand how this works. Until then, they shouldn't be allowed anywhere near economic policy.

Call me old-fashioned, but I miss the days when we valued hard work and success in this country. Young people today are encouraged to vilify those who have more. It seems to me a childish and selfish way to view the world.

In my youth, I had many low paying jobs. When I got tired of being broke, I applied for student loans, studied hard and became a nurse. If I wanted more money, I could go back to school and become a nurse manager or even a sur-

geon. Here's the thing: I don't want to. I'd rather not put forth the effort or incur the associated expense. Do I resent doctors because they make more than me? Not at all. Do I march in the streets and demand the same salary as a physician? That would be absurd.

Instead of browbeating Walmart and coveting thy neighbor's paycheck, maybe we should be inspiring people to educate and market themselves so they have skills employers need. I learned early in life that no one is going to pay me to sit around looking pretty.

## State Senator O'Connor Ives Advocates for Key Priorities in State Budget

The Massachusetts State Senate debated the Fiscal Year 2015 state budget last month where I advocated for key provisions that will be beneficial to the constituents of my district. Below are some of the notable district specific priorities that were included in the final budget:

- \$300,000 for the Methuen Stadium

This funding is vital to the City of Methuen to continue the momentum in providing a safe and modern environment for the residents of Methuen and visitors that utilize the stadium and will be used to apply toward renovating the athletic field area.

- \$175,000 for the Early College Program offered to Amesbury and Haverhill High School Students through Northern Essex Community College.

The Early College program is an opportunity for high school students to take college level courses and earn college credit while still in high school. This program helps prepare students for college, and also saves students money and time. To date, Haverhill and Amesbury have participated in the Early College program. Amesbury's most recent school budget cut the city's Early College program. This money will restore the initiative so students can continue to take advantage of this educational opportunity.

- \$90,000 for the C-10 Research & Education Foundation of Newburyport for the purposes of providing radiological monitoring of Seabrook Nuclear Power Plant.

The C-10 Research and Education Foundation (C-10) was established in 1991 to address the health and safety

issues related to the Seabrook Station nuclear power plant. C-10 evolved from citizens within the 10 mile radius, a 5,000 member organization founded in 1986 to challenge evacuation plans for the Seabrook Station reactor. C-10 is the only citizens' radiological monitoring organization in the country that has monitored emissions from a nuclear reactor from the moment it generated energy. Funding this program would assist in independent citizens' monitoring of airborne radiation levels within the ten mile radius of Seabrook Station reactor. This data is compiled and graphed, with monthly reports submitted to the Massachusetts Department of Public Health and MEMA.

- 90% funding reimbursements for regional school transportation costs that benefit Merrimack and Salisbury.

Regional School Transportation is a critical form of funding for our regional school districts, Pentucket and Triton Regional School District. These schools developed with the incentive of being able to rely on 100% reimbursement of transportation costs. In the past few years, progress has been made toward reaching the statutory mandate of 100% reimbursement, but there is still work to be done.

- Up to a \$25 million transfer from consolidated net surplus to the Community Preservation Trust Fund which directly assists North Andover and Newburyport.

This allows adopting communities to establish a dedicated local fund for open space, parks, playgrounds and athletic fields, and preserve historic buildings, natural areas and farmland.

- \$2.5M in new funding for the Shannon

Grant program, for a total funding level of \$8.25M that will make more money available for Merrimack Valley municipalities when applying for grants.

The Shannon Community Safety Initiative grants are awarded to communities with high levels of youth violence and gang problems to create anti-gang programs and provide extra patrols to curtail violent activity.

- The Foundation Budget Review Commission will be reconstituted, requiring the Commission to determine the educational programs and services necessary to achieve the Commonwealth's educational goals.

The Commission was established in 1993 in Chapter 70 of the General Laws, but has only met two times over, the last time decade. Under this amendment, the Commission would convene to fulfill its duty to examine the foundation budget and report back to the legislature next year.

- \$25,000 to promote recreational activities along the Merrimack River through the River Cities Initiative.

One of the most valuable resources and economic treasures connecting my district is the Merrimack River. Being able to travel from Haverhill to Newburyport on the Merrimack will grow small businesses, attract people to restaurants and historic attractions and promote recreational activities such as rowing through school sports and public use.

- Policy from a bill I filed was included through the budget process which would require a nursing home, rest home, or other long term care facility to first obtain



informed written consent if psychotropic medications are to be administered, along with a description of the side effects.

Prior to this legislative change, there was no state regulation or law requiring doctors or nursing homes to notify families that anti-psychotic or other psychotropic medication are being prescribed.

I look forward to expanding upon additional important items included in the FY15 State Budget in next month's column.

## HOT Doggity It's HOT out There!

Wow! The next couple of days may be record breaking HOT!! Summer vacation is here and everyone is enjoying this beautiful weather. We are planning our trips to the beach, hanging out at the pool and cooking on the grill. With all this excitement are you remembering your pets? As hot as you are, their body temperatures are higher and they can become dehydrated much quicker.

Like humans, dog and cats bodies are made up of 80 percent water. Having enough water in an animal's system determines the proper flow of nutrients needed for the functionality of the organs and helps prevent illness.

But more simply put . . . it's HOT and your pet needs water. He is thirsty!

As a rule of thumb, a dog needs approximately twice as much as its body weight to remain hydrated. For example: a dog that weighs 15 pounds should have at least 30 ounces of water a day.

- Keep the water bowl full all day. This time of year keep multiple bowls in easy access places to where your pet may be.
- Keep the water bowl clean. I have seen so many of these water fountains for pets, and owners fill them up thinking they don't need to change the water until it is empty. Hum . . . probably not one of my favorite pet inventions; people tend to forget it is "still" water in that container at room temperature. It needs to be changed and the container needs to be cleaned. If not, bacteria and mold will grow inside. Once ingested by the pet, mold can lead to severe internal sickness.
- Ice Cubes. Dogs love chewing on ice cubes, it helps get fluids in their bodies and it is a fun interactive toy, too!
- Dog pools, sprinkler or hose. Take the kiddie pool, fill it up with water and let your dog jump around in it. Oh my

god, have you ever seen a dog in a kiddie pool? They bounce all around and have a blast, too. If you don't have a pool, a sprinkler or a garden hose can be just as effective.

• AC or Fan. Yup . . . spoil your pet a bit. My Lani, she loves her AC and ceiling fan as she lounges on her couch.

If you have concerns that your dog or cat may be dehydrated do the "scruff" test:

To determine the extent of your pet's dehydration a dehydrated dog or cat will lose skin elasticity. Pull lightly on the skin at the scruff of the neck and note how quickly it returns to its normal location. The longer it takes, the more dehydrated your dog or cat is. And as always, with any health questions or concerns please call your veterinarian immediately.

Now that the sunny warm weather is here, fill the ice cube trays, buy some Frosty Paws treats and enjoy a happy and hydrated summer with your pets.

community, and when a traumatic event happens, like the suicide of 16 year old Colby Kenny in 2011, "the worst thing you can do is not talk about it."

Junior, Megan Munroe said the author's presentation helped her relate to living with her 5 year-old brother. "It made me feel like it's ok to want to protect him from violence on TV, and that other people feel that way too."

MacDonald's talk was followed by an interactive presentation entitled "Fostering Resilience in the Students," a group discussion among faculty, social workers and members of the Lawrence Antiviolence Youth Team, including Carlos Aredondo, Courtney Breen and Tammy Cancel. The youth team discussed their Safe and Successful Youth Initiative, with the goal of reducing youth homicides and serious assaults in Massachusetts.

Although the Lawrence group works with a more racially diverse population, the common thread is how much the North Andover and Lawrence youth populations have in common. For starters, some of the kids literally live down the street from one another, and it is easy to forget that there are poor families in North Andover too. A code of silence can manifest in any household or any community. Then there

is this dirty little secret: Helping fuel the Lawrence based drug trade is the purchase of drugs by people from more affluent communities - like North Andover.

Bilton observed that in the letters his kids sent to MacDonald, they spoke of having to cope with familial issues of loss, incarceration, substance abuse and suicide. Bilton found it curious that no one spoke about these sensitive issues in class, yet the angst was apparent in their letters.

When MacDonald spoke to kids in Lawrence, he said they were 10 times more vocal when discussing traumatic experiences. Is it possible that the more affluent communities are under pressure not to show the kinks in their armor? MacDonald said in some ways these tight-lipped kids are more at risk because they are less likely to talk about things that trouble them.

They ended the discussions with plans for the two communities to work together, creating an intentionally diverse peer-led group of students from both communities. The ultimate goal would be to foster a supportive sense of community and for these young adults to share common experiences. All in all, it promises to be a very positive and healthy project for all, but especially for at risk youth in the area.





## "Don't blame Massachusetts for New Hampshire's Leftward Drift"

In New Hampshire politics there is a widely held but grossly inaccurate myth. For Republican believers in the myth, it is a source of significant resentment. For Democrats who believe this myth, it instills confidence.

For decades, New Hampshire was a reliably Republican state. From 1960 to 2000, New Hampshire went for the Republican candidate in eight of 11 presidential elections. In fact, the Granite State was stocked with such great Republican talent that it was an incubator of GOP statesmen at the national level – leaders such as John Gilbert Winant, Sherman Adams, Meldrim Thomson, John Sununu, Warren Rudman and Judd Gregg.

Then something happened. New Hampshire suddenly became much less reliably GOP. In fact, we have not gone Republican in a presidential election since 2000 and haven't elected a GOP governor since 2002. So what happened? How did a once staunchly conservative state lose its political identity so quickly? The conventional wisdom is a simple but grossly inaccurate explanation. In short, it's all Massachusetts' fault.

Life-long Granite Staters remember a New Hampshire much different than the one they see today. They remember a

fiercely independent, Yankee conservative state. Today, they are nauseated by a community that voted twice for Barack Obama. To them, this radical transformation is easily explained. Attend any Republican gathering in New Hampshire and you will hear loud grousing that Massachusetts has "infected" and "ruined" the Granite State.

However, as is often the case with conventional wisdom, it is simply not true. According to a recent University of New Hampshire (UNH) Survey Center study, the facts tell a much different story. The majority of New Hampshire residents are transients. In fact, less than 40% of adults who live in New Hampshire were born here. That is the lowest percentage of any New England state. So where have the majority of Granite Staters come from? The answer is Massachusetts but the influx of Bay Staters and New Hampshire's recent liberal voting pattern are not interconnected.

The UNH survey of Massachusetts transplants found that the top three reasons residents fled the Bay State were cheaper housing; lower taxes; and escaping Massachusetts liberalism. Not exactly the responses you would expect from former residents of the only state in the nation to vote for George McGovern in 1972.

The southern part of New Hampshire is where most Massachusetts transplants have settled, and it is now the most conservative part of the state. When I served in the New Hampshire legislature, I represented the towns of Salem and Windham – both of which border Massachusetts. In getting to know my constituents, I quickly realized they were shell shocked tax refugees. They escaped Massachusetts for the very reasons the UNH survey cited and the last thing they wanted to do on Election Day was turn New Hampshire into the high tax wasteland they fled.

So what is the cause of New Hampshire's political leftward drift? The UNH survey also answered that question. The real culprits are residents from the Mid-Atlantic States: New Jersey, New York, Pennsylvania, Delaware and Maryland. They move to New Hampshire to escape city life in exchange for rural our natural beauty. Unfortunately, they bring their big-government liberal philosophies with them. They have relocated to New Hampshire in similarly large numbers as Massachusetts transplants. In fact, many of New Hampshire's most recent Democrat leaders have hailed from these states. Former Governor John Lynch hails from Pennsylvania, Speaker of the New Hampshire House of Representative Terie Noreli is from New Jersey, former Congressman

Paul Hodes is from New York, and Congresswoman Carol Shea-Porter was born in New York and worked in Maryland.

Not only are the Mid-Atlantic States producing liberal voters but they are making up the leadership of the New Hampshire Democratic Party. It certainly puts the absurdity of Democrat attacks against Scott Brown being a Massachusetts transplant into perspective.

Ronald Reagan, who New Hampshire supported in 1980 and 1984, once said that it is "worthwhile to find out how images are created — and even more worthwhile to learn how false images come into being." It may be easy for New Hampshire Republicans to look south and blame its political misfortunes on the myth of Massachusetts transplants but it is a false image that masks reality. New Hampshire will never again be a conservative state as long as we continue to lazily misdiagnose our real electoral problems and fail to accurately address them.



memorize things for the sake of memorizing them.

"They all have cell phones. If they need to know something right away they can look it up. Do they need to know the names of the states or the state capitals? I mean it's good to know that, but we teach; how they became states and what divides the states, what resources do they have that created those individual states, how are they governed differently and how does that affect them. It's more important they get the bigger picture rather than just memorizing the names of the capitals."

### DIFFERENT FROM OTHER SCHOOLS

Hampstead Academy has an advantage over public schools because they are able to structure learning around each child while public schools teach to the masses.

"It's hard to change the mindset of the industrialite," Kutzleman says. "The public schools have too many kids in a school, they have to get through all these common core type standards and sometimes that really inhibits the really good teachers from doing what he or she feels is right for her kids in that class at that time. Not all classes are the same, dynamics change. You may have certain children at one age that are functioning at a lower level and some that are really high. How do you deal with that in one classroom? Well, we can."

"I spent time on the local school board here in town" Stewart added. "I got to know the teachers really well, even the teachers who really are teachers in every sense, they express frustration since that inclusion law was passed. Inclusion is where children that used to be segregated because they had learning disabilities or special needs are now put into the same class with kids that don't have learning disabilities as well as kids that are gifted and talented. With all of those students at different levels of learning all in the same group, the teachers have to teach to the middle of the road. Many bemoan the fact that the really bright, talented kids are left hanging. There is a lot of focus on the kids that are needy but the kids at the other end are not being taught at the level of their potential. They need to be nurtured, their needs are just as important. So, maybe it's politics, there's no political traction around recognizing that those kids are every bit as needy and deserving of having their talents stimulated as the kids at the other end."

Hampstead's Headmaster Sam Richards says that he sees the benefits of whole child learning every day.

"My favorite part of the day is when I do my rounds and I walk through every classroom and just say good morning or good afternoon to the kids and the teachers. It gives me a chance to see what they are doing in the classrooms to see the wonder and joy they are experiencing.

One day I walked into a classroom and the 1st graders were stacking Oreos to see how high they could get it and then using the data to do a math equation. One of the nice things about a school like ours is you can structure the time to whatever project you are doing. For example, the art class I was helping kids with last fall was an hour and 45 minutes long, not just the 45 minute structured block of time you get in other schools. So, the kids have time to get into the project. I think we finished our project in two classes whereby if you had a structured block of time it would have taken them much longer and they wouldn't be as connected or excited about it."

Richards says that while most headmasters spend the bulk of their time with discipline issues there are almost no discipline problems at Hampstead.

"We instill values. Probably the most important thing that quest for lifelong learning gets woven into the child. There

aren't many schools that do that, in fact I don't know of any."

### CAN YOU AFFORD NOT TO SEND YOUR KIDS TO HAMPSTEAD ACADEMY

"Many people don't even think to look at private school because of a cost factor," Kutzleman said, "or kids don't want to leave their friends in the school they are in. But, if they are able to make a choice they should really look at this school."

Headmaster Richards agrees. "One way to look at it is an investment in your child's future. If you think about the opportunities for a child to develop their passions and have a chance within the context of a classroom to do that, you owe it to your child to do it. We have classes where the teachers will get into a project and go a week longer because the kids are so fired up about it. Here there are opportunities to be involved with art, music and drama while integrating the other courses into what they are learning, it's an invaluable investment. A lot of the other schools have cut those things and here we use them as additional tools to teach them all the other subjects. You just can't get that in other schools."

Chairman Stewart says he sees it as an obligation to the world.

"This may sound a little farfetched but it's not. The world has a lot of problems that in my estimation are only getting worse. They are complex, they're global, they're multicultural, and there is a huge need for thought leaders not only in the area of mechanics and engineering but in social skills, in sociology, and how do we get people to get along and collaborate? So, I say if you have a child who is really bright, I wonder if you don't have a responsibility, not only to yourself or to your child but to the world to get that kid here and take a look at what we do, because we can inoculate that child and that child might be a force for the future of the planet."

"I hate to see a really bright kid get frustrated and lose out on an opportunity because the world, the community loses out on what they could contribute if they were given the chance to reach their potential by challenging them and letting them grow. We need to be producing the thought leaders of the world and if that costs you as a parent, \$13-16,000 a year that's a really small investment given what it is going to produce."

Extreme would be bypassing Congress and ruling by executive order ("I've got a phone and a pen.")


Extreme would be incarcerating a teenage girl against her and her parents' wishes due to differing medical opinions (Justina Pelletier).

# 7 Dangerous Apps That Every Parent Needs to Know About

I work in public relations at Cook Children's. It's my job to be on social networking sites, peruse the internet and keep up with the latest Apps offered on smartphones. It's a great job and I love what I do, but over the last couple years, I have learned so much about the dangers of Smart Phone Apps. It's downright scary.

Technology, especially if you're a little behind the times, can be very deceptive. Your kids may be downloading Apps that you think are innocent and just a simple way for them to keep in contact with their buddies, but unfortunately, this isn't always the case.

To keep your children safe, it's best that you monitor their phone. Look through their apps, texts and pictures. They may feel that you're invading their privacy, but let's be honest... You're paying the phone bill, so you can do whatever you want! So, as you monitor your kid's phone, keep an eye out for these 7 apps you may not be aware of, that in my opinion are very dangerous:

**Yik Yak** – This App is one of the newest and one of the most dangerous. It allows users to post text-only Yaks of up to 200 characters. The messages can be viewed by the 500 Yakkers who are closest to the person who wrote the Yak, as determined by GPS tracking. Users are exposed to – and contributing – sexually explicit content, abusive language and personal attacks so severe that schools are starting to block the App on their Wi-Fi. Although the posts are anonymous, kids start revealing personal information as they get more comfortable with other users.

**SnapChat** – This App allows users to send photos that will disappear after 10 seconds. Once the recipient opens the picture, the timer starts. Then it's gone. From both the sender's phone and the recipient's phone. However, the recipient can take a screen shot of the photo and have it to share with others. This App enables kids to feel more comfortable "sexting" with peers.

**KiK Messenger** – This is a private messenger app and is coveted by those under 18 for a number of reasons. The App allows kids to send private messages that their parents can't see. There is very little you can do to verify the identity of someone on Kik, which obviously poses the risk of sexual predators chatting with your child. And again, this is an easy tool for sexting.

**Poof** – The Poof App allows users to make Apps disappear on their phone with one touch. Kids can hide every app they don't want you to see on their phone. All they have to do is open the App and select the ones they don't want you to see. Very scary! The good news about this App is it is no longer available, which isn't uncommon for these types of Apps. But, if it was downloaded before it was deleted from the App store, your child may still have it. Keep in mind that Apps like this are created and then terminated pretty quickly by Android and Apple stores, but there are similar ones being created constantly. Some other names include: Hidden Apps, App Lock and Hide It Pro.

**Omegle** – This App has been around since 2008, with video chat added in 2009. When you use Omegle you do not identify yourself through the service – chat participants are only identified as "You" and "Stranger". You don't have to register for the App. However, you



can connect Omegle to your Facebook account to find chat partners with similar interests. When choosing this feature, an Omegle Facebook App will receive your Facebook "likes" and try to match you with a stranger with similar likes. This is not okay for children. There is a high risk of sexual predators and you don't want your kids giving out their personal information, much less even talking to strangers.


**Whisper** – This is a meeting App that encourages users to post secrets. You post anonymously, but it displays the area you are posting from. You can search for users posting within a mile from you. A quick look at the App and you can see that online relationships are forming constantly on this App, but you never know the person behind the computer or phone. One man in Washington was convicted of raping a 12-year-old girl he met on this App just last year.

**Down** – This application, which used to be called "Bang with Friends," is connected to Facebook. Users can categorize their Facebook friends in one of two ways: they can indicate whether or not a friend is someone they'd like to hang with or someone they are "down" to hook up with. The slogan for the App: "The anonymous, simple, fun way to find friends who are down for the night." If that alone doesn't scare you, I don't know what will!

I know it's overwhelming to keep up with your kids and their online habits. But just remember to check their phones often, and even more importantly have real life conversations with them. Discuss the dangers of the Apps and make sure they understand the need to keep personal information private.

Please note: You can turn location services, or GPS, off on cell phones by going in to the device settings. This will keep the Apps and photos from posting the exact location or whereabouts of the phone user.





## Coffee, Can it Be Good for You? What's the Evidence?

Without my even asking, people will say to me that they don't drink coffee for health reasons. I have always found this perplexing, since I typically drink 2-3 cups in the morning, almost every morning since I was in high school, and never considered it to be a "bad habit". Of course, too much coffee can cause health problems, but what is underappreciated is its potential health benefits when taken in moderation.

There is an enlarging body of evidence that can give us insight and guidance on what may be the truth on the topic of the benefits and risks of coffee consumption. It is important to distinguish coffee, which is a brewed beverage made from roasted and crushed coffee beans, from other artificially caffeinated beverages (so called sports, energy drinks, and caffeinated soda). Since coffee contains ingredients other than caffeine, we need to consider that coffee also contains many other important and health promoting components.

Coffee is one of the richest sources of antioxidant compounds in the Western diet. Antioxidants are simply plant-derived molecules, including some vitamins, which we eat, that have important chemical properties. Antioxidants are believed to soak up "free radicals" which are created by our body's metabolism, or chemical reactions that we use to extract energy from the food we eat. Since "free radicals" are believed to cause damage to the cell and its components, antioxidants are believed to balance the oxidative damage of free radicals. Coffee happens to be rich in antioxidants including flavonoids, and in essential minerals including magnesium and chromium. Sports drinks and soda have none of these beneficial substances.

There are unfortunately no studies that prove cause and effect, and there probably will never be such studies because they are not practical to do. There is however consistent observational evidence that show a protective effect from coffee consumption against liver cancer and from liver cirrhosis.

The Nurses Health Study showed a 20% risk reduction from stroke for those who consumed at least two cups of coffee a day, compared with those who consumed less or none. A Kaiser Permanente study showed a 20% lower likelihood of being hospitalized for abnormal heart rhythm (arrhythmia) at a level of 1-3 cups a day, compared with non-coffee drinkers. Coffee consumption is associated with a lower risk of developing Parkinson's disease, and a Finish study that looked at consumption of coffee over 20 years

showed a 65% reduction in the incidence of Alzheimer's disease and dementia. Increased coffee consumption correlated with a consistently lower risk of type II diabetes in European, US and Australian studies.

There are of course certain situations where coffee, particularly too much caffeine can be a health concern. Safe consumption levels have not been established in pregnancy. Caffeine can be habit forming at higher levels of consumption, and caffeine overuse and withdrawal can manifest as headache, anxiety and sleep problems. Persons with complicated acid reflux disease can worsen with increasing exposure to coffee and caffeinated beverages. Caffeinated, but not decaffeinated coffee is a mild diuretic, and can lead to dehydration in certain settings. Persons with bladder and prostate problems should seek individual professional medical advice. Sports and energy drinks in particular have super high doses of caffeine, sugar and other stimulants and have been associated with cardiac arrhythmias, which can be fatal. Not for me, I'll stick with the natural brew.

Good health is rich interaction between lifestyle, genetics, environment, and luck to some degree. There is no magic substance that is guaranteed to protect from every disease, and we all know that too much of a good thing is usually not such a good thing.

There is however quality observational evidence, remarkably consistent, that coffee consumption really can be a part of a healthy lifestyle, especially in moderate amounts. Be careful about diluting its benefits (pun intended) by adding too much sweetener, cream and artificial flavorings. I never feel guilty about consuming coffee when talking with health professionals, and find it surprising when people feel this way when speaking with me. I think the evidence is on my side.

## State Agencies for Employment Rights

For this month's article I decided to describe the various Federal and State agencies that enforce employment laws in Massachusetts. I have listed the names of the agencies, along with contact information, and a brief description of the services that they provide:

**Massachusetts Office of Business Development:** This office is the State's principal business development agency. It assists in the expansion and location of business and is responsible for promoting Massachusetts as a business location. Located at 100 Cambridge Street in Boston. Telephone number 617-788-3695.

**Department of Business Development:** This agency works to promote the development of business and industry, travel and tourism, science and technology, international trade and women and minority business development in the Commonwealth. It is also located at 100 Cambridge St. and they can be reached at 617-788-3605.

**Civil Service Commission:** A quasi-judicial body to which appeals may be addressed regarding the merit system in public employment. It can review, for example, original and promotional bypasses, and the discharge, removal, suspension, transfer or reduction of rank of civil service employees. The employee must, however, be a civil service employee in order for the agency to have jurisdiction. I usually tell clients that unless you are aware that you are a civil service employee you probably aren't one. Not



all "Public Employees" are civil service employees. The agency is located at one Ashburton Place and the telephone number is 617-727-2293.

**Commission for Deaf and Hard of Hearing:** This agency helps deaf and hard of hearing get some of the aid/services that help the hearing impaired to function within the workplace. Located at 150 Mt. Vernon St., Dorchester, MA.

**Massachusetts Commission Against Discrimination:** Enforces MGL 151 B which prohibits discrimination in employment in regards to Race, Color, Religion, National Origin, Ancestry, Sex, Maternity and Sexual Harassment and Age if the employee is 40 or over. Also, Criminal Records on Applications, Handicap, Mental Illness, Maternity Leave and Sexual Orientation and Recovering Addicts. The agency is located at 1 Ashburton Place in Boston and can be reached at 617-994-6000 or in Springfield at 413-739-2145.

The Division of Human Resources is also located at 1 Ashburton Place and is responsible for the establishment and maintenance of a merit system of person-

The Department is located at 1 Ashburton Place and the telephone is 617-626-7122. Also the Department of Labor is located in the same building and is responsible for the enforcement of the

wage laws of the state, 617-626-7100.

Division of Occupational Safety administers workplace safety and health programs which also includes issues of wage scales for public works projects i.e. "prevailing wage rates". The department has offices in Haverhill, New Bedford, Pittsfield, Springfield, West Newton and Westborough.

Public Employee Retirement Administration Commission which oversees all of the 106 public pension systems in the state including city, town, county and state pensions.

Hopefully, while this is not a comprehensive list of all of the agencies that are in some way connected to Employer/ Employee issues within the state, it will be of some help. Remember if you have an employment issue, it is a good idea to talk with an experienced employment attorney before taking any actions.

# What I have learned in my 44 years in Hypnosis

When I read my first book about hypnosis, it was the great Ormond McGill's "Encyclopedia of Stage Hypnotism." It was on Labor Day 1969.

At that time, I read the "Hands Clasp" script to my father in law and it did not work! That was OK and in November of that year I took Harry Aron's weekend seminar in Boston, Massachusetts. I loved it!

Since I had some acting experience in local small theater, I leaned towards stage hypnosis and started to follow a Canadian stage hypnotist, Sam Vine who was appearing frequently in my home town. Later, Sam and I became good friends and he taught me quite a bit about stage hypnosis. Without belaboring my career in stage hypnosis, let me just say that it has been an extremely rewarding and enjoyable journey in my life.

At the same time, I did partner with Burt Seavey in Lynn Massachusetts who had converted his garage into a nice little office where I would watch him administer hypnosis to clients.

I also felt that I should further my education and attained a Bachelor's degree with Empire State College in Saratoga Springs, NY. Thirteen months later I received my Masters degree in Hypnotherapy and Psychology from Norwich University in Montpelier, VT. Both degrees are accredited and were obtained through the "External Degree Program," formally entitled "University Without Walls."


I then became certified with the AAETH - The association to advance Ethical Hypnosis which was headed by Harry Arons and then I also became a certified hypnotist with the National Guild of Hypnosis (NGH) in which I have been associated with for over 20 years. It has been a wonderful association as I watched, and hopefully I helped, the NGH grow into the giant organization that it is today. The NGH is the largest, most friendly educational teaching organization in over 73 countries.

I learned by working with thousands of clients that no matter how deeply a person goes into hypnosis, nobody actually knows if that person will accept or reject our suggestions.

I have learned that if I can get that person to feel good about himself/herself, then they will accomplish their goals in most cases.

As Harry Arons once said "The only thing that you can be sure of about hypnosis, is that you cannot be sure of anything!" You never know how a person is going to react and follow your suggestions, or not.

I have learned that when you find a common goal with a client, the door opens up and you then have rapport. For example,



if I ascertain that this client is a golfer, and I have made a DVD for golfers, then we have a connection and they usually become more open and responsive to me and the suggestions that follow.

I have learned that testing is something a client CAN accomplish while a challenge is something that he/she CANNOT accomplish. A perfect example of that is the "HANDS-CLASP" experiment. First, the client is able to lock his/her hands and then it switches to a challenge whereby he/she cannot unlock their hands.

I have learned that challenges such as the "Eye Catalepsy," the "Hands Clasp," and perhaps the "Ideo-motor" response whereby he/she cannot stop a finger from going up and down no matter how hard they try will help to deepen the level of hypnosis.

I have learned that when I use the word "Receptive" rather than "Suggestibility," it makes it a bit easier for the client to accept and follow your experiments. To me, the word suggestibility has a slight connotation of gullibility. Now, don't get bent out of shape on this theory of mine. I know that millions of very good hypnotists use the word "Suggestibility," and that is fine....it is just my own feeling about it.

I have learned that if I make a cassette tape of at least the first session, and if the client actually listens to it for 21 days, my success rate goes up. I believe that all hypnosis might be temporary unless it is reinforced. There are several ways to reinforce the suggestions. One is to have the client come back for repeated sessions. The other is to tape the sessions for them.... remember to give them the tape. I have, at times, left the tape in the recorder and then have to scramble to get the tape to the client. Another way to reinforce is to teach the client Self-Hypnosis. These are just a few methods of reinforcement.

I have learned that when a client is not doing well with the program, then you need to search for the cause of the problem a little bit deeper. They probably have other

I love brownies! Who doesn't? OK, OK, I know there are a few of you out there. But I also love lemon & although I have had many versions of what I'm calling lemonies, but they are almost always very cake-like. What I have been trying to find is a recipe that makes ooey, gooey, chewy lemonies. THAT has been darn near impossible...until now. I think I've done it! What do you think?

**Lemonies**

- 1 c room temperature unsalted butter, NO substitutes
- 2 c sugar
- 2 lemons, zested
- Juice of one lemon
- 3 room temperature large eggs
- 1 t vanilla
- ¼ t salt
- 1-1/8 c flour

Preheat oven to 350°F. Butter a 9" x 9" square pan. Place a sheet of parchment paper on the bottom. Butter the parchment paper. Flour the pan.

Into a mixer bowl, place the butter & sugar. Cream well with an electric mixer. Add eggs, zest, vanilla, lemon juice, & salt. Beat well. Scrape down bowl. Add half of the flour & mix until barely incorporated. Add rest of flour & mix until barely incorporated. Scrape down bowl & ensure that all is just incorporated.

Place all batter into pan & smooth it out evenly. Bake until the lemonies have puffed slightly around the edges, the surface is shiny, but batter is still very moist in the centre. This will take about 30 minutes.

Remove pan & place on cooling rack. Cool completely before cutting. Makes 9 bars.

My favourite fruit is a mango so it seemed like a natural thing to make a savory dish with them. This is not a super-sweet dish despite its name. It's a fairly quick dish to actually make; the long time being the marinating time. It's light, delicious, & won't leave you feeling stuffed.



Serve it over rice or not as you see fit. I used brown rice here.

**Honey, Mango, & Sesame Chicken**

1.5 lb. chicken breasts or 1.5 lb. chicken thighs, cut into 1.5" pieces

2-3 ripe mangoes, quantity depends upon size, peeled, de-pitted, & cut into 1" chunks, room temperature

¼ c sesame seeds, toasted

¼ c mango chutney

2 T honey

2 T grated fresh ginger

½ t cayenne pepper or to taste

½ c chopped fresh cilantro (or flat leaf parsley)

¾ t salt

½ t pepper

2 medium onions, cut medium dice

2 c rice, optional

Into a non-reactive e.g. glass bowl, place all ingredients except rice, cilantro, sesame seeds, mangoes, & onions. Mix gently but well. Cover & refrigerate at least 6 hours or overnight. Bring to room temperature prior to cooking.

Prepare the rice according to package instructions, if serving over rice.

Heat a large sauté pan or skillet on high. Add 3 T canola oil. Add all contents of bowl & onions. Sauté until chicken is cooked through & onions are lightly browned on the edges. Add the sesame seeds. Mix well. Add the mangoes. Gently mix. Cook about 1 minute. Transfer to serving dish. Serve either plain or over rice. Top with cilantro or parsley.

**Frauds Get Away Free When the Press Fears Asking Questions**

"All animals are equal, but some are more equal than others." - George Orwell

Valley Patriot readers read last month about the mind-boggling fraud associated with Sir Donald Berwick and his close friends Dr. Lucian Leape and Dr. Charles Denham. Readers also were introduced to the corrupt recommendation from Sir Donald Berwick on US Government letterhead when he was Obama's recess appointee. The Supreme Court just condemned 9-0 Obama's recess appointments.

Dr. Leape's 2013 paper asserting his LeapFrog Score is valid was not his first fraudulent paper published at Harvard. Dr. Leape originally shot to fame with a deliberately fraudulent paper in 1991 and reasserted in 1999 as a Report ("To Err Is Human") from the Institute of Medicine in Washington DC which claimed American doctors kill 44,000 - 98,000 Americans every single year due to negligence even though the 1991 paper said "98,000 adverse events" not "deaths."

That 1999 Report ignited the fraud called the LeapFrog Group and set it in business nationwide. Leape recommended LeapFrog by name in that Report without disclosing that Leape founded LeapFrog.

The interesting thing about fraud is that it requires people to believe. In the case of the IOM, people are expected to believe that it is part of the National Institutes of Health, meaning the United States Government and that it's Reports are issued in the public interest and deserve unquestioning respect and obedience. Nothing could be further from the truth. The IOM is just a private non-profit like so many others that don't pay taxes and claim to be noble.

The Kansas Feds revealed the corrupt role of Dr. Charles Denham in trying to influence the Report of the National Patient Safety Foundation. He was bribed \$11.6 Million. This concern applies equally to Reports issued by the IOM.

## State Senate Candidate Finocchiaro Off and Running

Methuen Democratic State Senate Candidate has been busy this past month. Between attending district events to introduce herself to hundreds of people, knocking on doors, and her recent kickoff event she has stayed visible to voters.

The Committee to Elect Jessica Finocchiaro held a campaign kickoff at the Methuen Sons of Italy June 26th, and despite a few other events going on, attracted over 100 people. The room was filled with supporters from elected officials, to small business owners, to a diverse group of residents who are all standing with the campaign through Election Day September 9th. Former Mayor of Methuen and current Town Manager of Seabrook Bill Manzi as well as former State Senator, Massachusetts Secretary of Energy, and Mayor of Methuen Sharon Pollard both gave speeches in support of Jessica noting her honesty, loyalty, ability to get things done, and even made some comparisons to JFK.

Finocchiaro says, "I believe voters are receptive because they want to know who the candidates are personally, not just a set of talking points. They know that our district and the Commonwealth are facing some serious issues, and voters want to know how I will be different. I've heard from people across the district, and many agree that if we keep electing leaders who won't stand up our families and issues that have an everyday impact—things will continue to get worse. My family and I have been through some tough times, and that's what has motivated me to bring my perspective to public service. With me you know I will not waiver in standing up for families like yours."

Jessica says that voters like her straightforward attitude best. She says, "Voters ask me all kinds of questions, and they should. There is a huge difference between the opinions of my opponent and I, so it's important that voters have direct access for the democratic process to really work."

The incumbent, Senator Kathleen O'Connor Ives, first won the Democratic Primary in 2012, with just 38 percent of the vote in a close three-way contest. Finocchiaro and Ives are the only two Democratic primary candidates, and one of them will face off with Haverhill Republican Shaun Toohey this fall.
